Professor Julie McConnell is Director of the UR School of Law's Children's Defense Clinic. Prior to joining the Law School in 2011, she served as the Supervising Assistant Commonwealth's Attorney in the City of Richmond's Juvenile and Domestic Relations Court, where she prosecuted cases involving juvenile delinquency, child abuse, sexual abuse, domestic violence, elder abuse, and homicide. She has also served as an Assistant Public Defender in the Richmond Public Defender's Office and is the author of an article in Virginia Lawyer Magazine on the collateral consequences of juvenile adjudications. In 2011, Professor McConnell received the Oliver Hill Juvenile and Domestic Relations Court's "Unsung Hero" Award. She was also awarded the Outstanding Woman Award for Education by the YWCA Richmond in 2017.

## November's Pro Bono CLE Presentation

Find Your Summer Hires Early

During the November luncheon's CLE presentation, Cris Gantz, from the Virginia State Bar, and John Whitfield, director of Blue Ridge Legal Services, helped us understand the pro bono gap, and the new voluntary reporting rule. The justice gap (between those who are represented in court and those who are pro se) has consequences for the vast majority of litigants in general district court, who, without a lawyer, are less likely to prevail. Helping to close the Pro Bono Gap ("the difference between the aspirational goals of Rule 6.1 and the actual performance of the bar as a whole in undertaking pro bono work each year") is the intention behind the new voluntary reporting provision of Rule 6.1. This will help gauge the amount of pro bono being done around the state, and hopefully encourage more lawyers to get involved (pro bono has been shown to improve lawyer happiness!).



The pro bono reporting rule goes into effect December first, and reporting will begin with next bar renewal statement. Since the entire bar year will count, you should look back to pro bono hours you performed beginning July 1 of this year (remember, this is voluntary, so you can choose not to report).

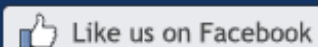
