**President's Message**

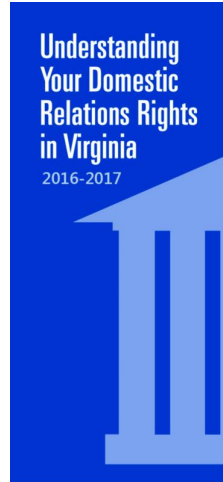
I am honored to serve as the President of the Metropolitan Richmond Women's Bar Association. I am grateful for the role this organization has played in both my personal and professional life. My relationship with MRWBA began when I was in law school, and requested a MRWBA mentor. My mentor invested her time in me, by giving me advice and guidance. I even obtained my first legal internship as a result of our relationship! At the time, I likely didn't fully appreciate the full value of the MRWBA mentorship program. But looking back, I realize that one of the most important benefits was that my mentor demonstrated to me in a concrete way how I could achieve both personal and professional success. I was emboldened by her success, and carried that confidence forward in my own career.

Following law school and a brief stint in West Virginia as a law clerk, I returned to Richmond and the MRWBA as a baby lawyer. In addition to enjoying the engaging program, I was warmly welcomed by each of the women at my table. I was hooked. MRWBA checked both boxes for me, in that I was intellectually stimulated and felt I was furthering my career, but I also enjoyed the people. I have been fortunate to meet and develop relationships with a strong, creative, diverse, caring and smart women. Each event and each member has inspired me in different ways: to do better, think harder, and care more.

My theme for the bar year is "Finding & Fostering Success." Defining success is challenging. Merriam-Webster defines it as "the fact of getting or achieving wealth, respect, or fame," but I reject that definition as too narrow and turn instead to Google. The founder of Huffington post, Arianna Huffington, accepts that money and power contribute to success, but argues that those goals must be paired with "well-being, wisdom, wonder, and giving." Thomas Edison famously described how to obtain success (especially for many lawyers) as 1% inspiration and 99% perspiration. Deadline in October 2017.

\*John C. Kenny Pro Bono Award, nomination deadline is August 26, 2017.

\*Hill-Tucker Public Service Award, nomination deadline is November 22, 2017.

\*Young Lawyer of the Year Award, nomination deadline is December 1, 2017.

Of course, please submit your nomination for MRWBA's Women of Achievement Award, which we bestow upon a deserving member (s) every year. Deadline is October 1, 2017.
